





## How to print the bill

- 1. Visit <a href="https://www.tatimineprone-rks.org">www.tatimineprone-rks.org</a>
- 2. Click print bill
- 3. Write your personal number, name and last name and the security text shown on the screen.

## How to pay the bill with e-banking

Follow the e-banking procedures of your bank.

To carry out the payment you need the Uniref code and your Municipality's Bank account.
